BOARDING CONTRACT

This agreement is entered into between **Ralston Valley Canine** and the owner/agent of the dog indicated below.

All fees are due and payable at the conclusion of boarding or upon demand. Non-payment of fees when due or checks that bounce may leave the contracting party liable under applicable Colorado Lien Statutes. Should legal resources be required for collection, damages shall include court cost and reasonable attorney fees.

Ralston Valley Canine shall provide medication and/or professional veterinary assistance to animals which become sick or injured while in the care of the kennel. Such fees that result will be the sole responsibility of the animal's owner. Upon notification of the owner (if possible) of illness, a suitable veterinarian of the owner's choice may be utilized, unless in the opinion of **Ralston Valley Canine** an emergency situation exists which requires immediate attention.

Ralston Valley Canine maintains adequate insurance coverage to protect the interest of the kennel, its employees, its physical properties and its business activities. **Ralston Valley Canine** will not be liable for the injury, diseased or death of any animal, if such conditions arise due to circumstances beyond its control.

Parties contracting herewith agree to inform **Ralston Valley Canine** of any dangerous behavioral tendencies of their animals, any illness or disease that the animal may have and whether the animal is currently in gestation or will soon be in estrus

All dogs left 30 days without full payment will be considered abandoned and **Ralston Valley Canine** reserves the right to sell, place or dispose of the animal.

All dogs must have Rabies, Distemper, Parvo and Bordetella vaccinations within the past 12 months. If an animal dies while in our care we will immediately transport the animal to Homeward Bound Animal Hospital, Arvada. Boarding charges are based on the following:

We charge for the first day regardless of what time the animal arrives at the kennel. Last day will not be charged if dogs are picked up *before* noon, but the full day will be charged after that time.

Sunday pick up and drop off 9-9:30 am and 7-7:30 pm only.
